She served as the Corporate Secretary to the Ontario Public Service Pension Trust from 2011 to 2014 where she advised a jointly trustee pension board. From 2006 to 2008 she was the Director of Policy for the Ontario Expert Commission on Pensions, also known as The Arthurs Commission.

She has several books and articles to her credit, in particular Pension Power, published by the University of Toronto and based on her doctoral dissertation, as well as books and numerous publications on pension finance and governance.

From 2003 to 2006, Isla was a post-doctoral fellow at University of Toronto. Since 2011, Chris has been a trustee of the Canada-Wide Industrial Pension Plan (CWIPP), a multi-employer pension plan established by the CLC in 1970. He is a research associate with the Canadian Centre for Policy Alternatives, and has published several works on pensions, including *The Contradictions of Pension Fund Capitalism* (Labor and Employment Relations Association, 2017), with Kevin Skerrett et al. Chris represents the CLC in international pension policy discussions, participating in the activities of the International Labour Organization (ILO) and the Working Party on Private Pensions of the Organisation for Economic Co-operation and Development (OECD).
