• Vice-President, Pension Fund and Chief Investment Officer

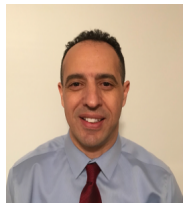
Chairperson of the Pension Advisory Council since: June 2022
